Pennock City Council held their regular monthly meeting on Tuesday, April 4, 2017 at 7:30 p.m. at the Pennock Community Center. Mayor Crowley called the meeting to order at 7:30 p.m.

Motion by Council member Arends to approve the March 7<sup>th</sup> Council minutes, Council member Miller seconds the motion. The motion passed.

The bills were presented. Motion by Council member Bastin to pay all the bills; Council member Arends seconds the motion. The motion passed.

Motion by Council member Arends to accept the Consent Agenda, Council member Bastin seconds the motion. The motion passed.
