

Pennock City Council Meeting
Tuesday, August 2, 2022

Pennock City Council held their regular monthly meeting on Tuesday, August 2, 2022 at 7:00 p.m. at the Pennock Community Center. The following members were present Mayor Kevin Crowley, Council members Jeff Arends, Bruce Bastin, Dave Miller and Karen Skaggs. Also present was Donavan Peters.

Mayor Crowley called the meeting to order at 7:00 p.m.

Motion by Council member Miller to accept the agenda as presented; Council member Arends seconds the motion. The motion passed.

Motion by Council member Arends to approve the Consent Agenda which consisted of the July 5, 2022 Council minutes and to pay all the August bills; Council member Bastin seconds the motion. The motion passed.

Deputy Riley Kampsen was not present for the sheriff's report but did present the report to Clerk Johnson. For the month of July there were 50.75 hours.

OLD BUSINESS

Amending Farm Animal Ordinance – Clerk Johnson presented a drafted ordinance that the City Attorney reviewed of rules and regulations. Due to not receiving a motion the ordinance failed.

Amending Establishment of the City Council – Clerk Johnson presented a drafted ordinance that the City Attorney reviewed with the change of a resident needs to be residing in the City of Pennock for a period of not less than six months. Motion by Council member Arends to introduce the ordinance for a public hearing; Council member Miller seconds the motion. Roll call vote was taken with Council member Arends, Bastin, Miller and Skaggs in favor and Mayor Crowley in favor. Motion passed.

Old Well – Clerk Johnson gave an update on the status of locating and sealing the old well.

NEW BUSINESS

Propane Contract – Dooley’s Petroleum contract price \$1.84 per gallon. Motion by Council member Miller to accept Dooley’s Petroleum contract price of \$1.84 per gallon; Council member Skaggs seconds the motion. The motion passed.

Emergency Ordinance Temporarily Regulating the Sale of Edible Cannabinoid Products in the City of Pennock – Motion by Council member Arends to introduce the ordinance; Council member Bastin seconds the motion. Roll call vote was taken with Council member Arends, Bastin, Miller and Skaggs in favor and Mayor Crowley in favor. Motion passed.

Council member Bastin inquired about what activities were happening for Pennock Fun Days due to nothing being brought forth to the Council.

OTHER BUSINESS AND ANNOUNCEMENTS

Elections – It was mentioned that Primary Elections is Tuesday, August 9, 2022 at the Pennock Community Center from 7:00 a.m. – 8:00 p.m. The General Elections is Tuesday, November 8, 2022 from 7:00 a.m. – 8:00 p.m. along with Pennock City council offices of Mayor (2 year term), Council members (two positions, 4 year terms each). Filing Affidavit of Candidacy period is August 2nd through August 16th. Filing fee for candidacy is \$2.00
