Pennock City Council held their regular monthly meeting on Tuesday, December 3, 2019 at 7:00 p.m. at the Pennock Community Center. The following members were present Mayor Kevin Crowley, Council members Jeff Arends, Bruce Bastin, Mackenzie Laughlin and Laurie Maresch. Also present was Donovan Peters and Deputy Levi Brown.
