# Pennock City Council Meeting Tuesday, February 5, 2019

Pennock City Council held their regular monthly meeting on Tuesday, February 5, 2019 at 7:00 p.m. at the Pennock Community Center. The following members were present Mayor Kevin Crowley, Council members Jeff Arends, Bruce Bastin, Mackenzie Laughlin and Laurie Maresch. Motion by Council member Arends to approve the Consent Agenda which consisted of the January 9, 2019 Council minutes and to pay all the February bills; Council member Maresch seconds the motion. The motion passed.

- Demo the house on the hill of Atlantic Avenue NE
- Park improvements
- Brush site

#### Laurie Maresch –

- Alley/sidewalk behind the Post Office
- Add things to town to make Pennock stand out
- Natural gas on the north side of town
- Fix the road on the north east side of town by the railroad crossing.

#### Kevin Crowlev -

- Sale of lots in Dirk's Fourth Addition
- Street improvement projects
- Christmas Lights
- Community Center windows
- Electronic sign
- House numbers on houses
