Mayor Crowley called the meeting to order at 7:00 p.m.

Motion by Council member Arends to accept the agenda as presented; Council member Bastin seconds the motion. The motion passed.

Motion by Council member Miller to approve the September 4th Council minutes; Council member Laughlin seconds the motion. The motion passed.

The bills were presented. Motion by Council member Bastin to pay all the bills; Council member Arends seconds the motion. The motion passed.

OLD BUSINESS

Dirk's Fourth Addition Lots – Council member Bastin inquired about sending letters to contractors promoting the lots. Mayor Crowley said that he would try putting a letter together to send to contractors advertising lots at \$7500.00 or negotiable.

NEW BUSINESS

MnWARN (Minnesota's Water/Wastewater Agency Response Network) – Clerk Johnson mentioned that the Resolution has been adopted but the Mutual Aid Agreement needs to be adopted to become a member. Motion by Council member Miller to adopt the Mutual Aid Agreement; Council member Arends seconds the motion. The motion passed.

Mower – The quote from Haug-Kubota was reviewed. Council member Miller made a motion to negotiate with Haug-Kubota on the freight and set-up charges; Council member Bastin seconds the motion. The motion passed.

Council member Arends mentioned that there were some cabinets that have been dumped out at the brush site.

Council member Bastin mentioned that he had a resident concerned about a dumpster in the back yard at the property of 209 Atlantic Avenue NW and a vehicle in the driveway with non-current tabs. Clerk Johnson mentioned that when she received an anonymous letter earlier regarding the dumpster, it was investigated at that time. She also mentioned that the vehicles with non-current tabs were also being worked on.

Mayor Crowley mentioned that on Sunday, October 21st there is going to be a pancake fundraiser breakfast at the Pennock Fire Hall from 9:00 a.m. – 1:00 p.m. with the proceeds going towards a thermo imaging camera for the Pennock Fire Department.
