Pennock City Council held their regular monthly meeting on Wednesday, March 2, 2016 at 7:00 p.m. at the Pennock Community Center. The following members were present Mayor Kevin Crowley, Council members Jeff Arends, Bruce Bastin and Terry Thole. Absent was Dave Miller.

Mayor Crowley called the meeting to order at 7:00 p.m.

Motion by Council member Bastin to approve the February 2<sup>nd</sup> Council minutes, Council member Arends seconds the motion. The motion passed.

The bills were presented. Motion by Council member Thole to pay all the bills, Council member Arends seconds the motion. The motion passed.

Deputy Ross Johnson was not present for the sheriff's report.

## **OLD BUSINESS**

Mayor Crowley gave an update on Natural Gas. He said that he spoke with Perry Schmidt from Center Point Energy and it looks like the South side will go this year and was still concerned with the North side, due to the boring that would need to be done and lack of interest. It was mentioned that we may have to go door to door to those who have not sent a survey back.

Mayor Crowley informed the Council of some changes that need to be made to the ordinances before we will look at adopting the final draft. It is a work in process but we are getting closer.
